Flood loss grants

THE Minister for Police and Emergency Services, Mr Pat Mc-Namara has authorised the payment of personal hardship grants to persons who have suffered losses in floods in central and north Victoria.

Mr McNamara today designated the floods an emergency justifying the granting of emergency financial assistance to flood victims.

Emergency grants activated by the Department of Health and Community Services can provide immediate assistance to people in urgent need of food, clothing or shelter. Up to \$280 per adult and \$140 per child to a maximum of \$700 per household can be provided.

The temporary Living Expenses Grant and the Re-Establishment Grant are activated by the Minister for Police and Emergency Services or the Premier, and are means tested.

Grants to a maximum of \$140 per adult plus \$70 per child, to a maximum of \$560 per week per household, to a maximum of 26 weeks or \$5600 can be made available. The Government can recover the funds if the recipient recovers through an award of damages or compensation.

VFF flood assessment

THE Victorian Farmers' Federation has called for a review of the state's flood warning system after central and north-east farmers suffered heavy losses caused by freak rains this week.

"There appears to be very little warning for farmers of imminent flooding in many areas of the state and the federation plans to work closely with Government to improve warning procedures," VFF president, Mr Bill Bodman said today.

"It will be some days or even weeks before the devastation can be properly assessed but early indications are flood damage to residential areas will be coupled with considerable losses in agriculture and its in-

frastucture," Mr Bodman said.

Farmers have not only measured losses in drowned stock but also on damage to fencing, bridges, irrigation eqiquipment and pasture, he said.

Rain has also affected farmers as far west as Boort, where tomato crops destined for processing have been decimated by local flooding, Mr Bodman said.

"Without doubt State and Federal Government assistance will be required to get devasted farmers back on their feet once the floodwater have dropped. The VFF will speak with relevant Ministers to ensure farmers' problems are adequately addressed," he

SOCIAL SECURITY SUPPORT

THE Minister Social Security, Mr Peter Baldwin said yesterday that departmental staff were making sure payments and services were still getting through to clients in flood-ravaged Victoria despite the difficult circumstances.

"Extra staff, including social workers, are operating in the flood affected areas to make sure that the needs of the communities are being met," said Mr Baldwin.

"They are providing support and information about Social Security

payments and are working closely with the Victorian Department of Health and Community Services."

Mr Baldwin pointed out that some people affected by the floods may be entitled to Special Benefit.

People in the flood stricken areas who need help form DSS should ring the Social Security Teleservice Centre on 13 2468. For information in languages other than English they should ring the Multilingual Telephone Information service on 13 1202.
