

BRADAAG appoints new C

THE Barkly's lead drug and rehabilitation service has appointed a new CEO.

Barkly Regional Alcohol and Drug Advisory Group (BRADAAG) has welcomed Suman (Sam) KC to its chief role, taking over from Pauline Lewis who resigned in September.

Sam (pictured) has been living and working in Tennant Creek for five years and previously held the executive manager role at the organisation, working closely with Pauline for three years to assist in the operations of the services.

An exceptional leader with a wealth of experience, connections to staff, external service and the local community, the BRADAAG Board of Directors has expressed its confidence in Sam's audacity and skills in building and inspiring teams.

Don't make decisions about us without us: NLC

THE Northern Land Council (NLC) has open. Once a safe vaccine is approved for called on the Territory Government to stop making decisions without it.

NLC announced this week it supports the call by the Aboriginal Medical Services Alliance of the Northern Territory (AMSANT) that a safe reopening of the Northern Territory must be based on a number of key principles and actions.

Prior to the recent COVID-19 transmission events in Darwin and Katherine, the NLC Chairman Samuel Bush-Blanasi emphasised that: "We need higher vaccination rates in the NT because 80 per cent ... is too low to protect Aboriginal people in remote communities. We need minimum of 90 per cent."

Mr Bush-Blanasi stressed the need to use the best information available, and based on the recent Doherty Institute updated data modelling, the NLC supports AMSANT's call for 90% coverage for Aborganal people over the age of 16 years before NT borders

children from 5 years of age, the NLC would support AMSANT's call for a revised target of 80 per cent.

Without an enhanced and targeted remote vaccination program, the NLC has concerns about the requirements, complexity and workability of rapid antigen testing and mask wearing in communities with a vaccination rate below 70 per cent.

"If we don't have reliable vaccination data outside of Darwin, Katherine and Alice Springs, then we won't know where to target our multilingual vaccination promotional efforts. Remember our Aboriginal land and waters border Queensland, Western Australia and South Australia and major towns across the NT too," said Mr Bush-Blanasi.

"This is about our lives, our people and our country. Governments have to think beyond the big cities when making important decisions about our mob out bush - don't make decisions about us without us.

Tennant remembers our fallen heroes

IN common with many other countries, Australia commemorates Remembrance Day at "the eleventh hour, of the eleventh day, of the eleventh month", which was known as Armistice Day in Australia until after World War II.

It marked the end of World War I, but has come to be a day of commemoration for not only the 45,000 Australian service personnel lost in WWI, but for all Australians lost in any conflict.

As always, Tennant Creek RSL held heartfelt service to honour the fallen, with wreaths being laid by Barkly MLA Steve Edgington, Mayor Jeffrey McLaughlin, as well as students from local schools and other organisations in town.

For those who were unable to attend the RSL, or those who are interested in the history of Australia in battle there will be a semi trailer cinema session at the IGA car park from 7pm till 9.30 tonight. Originally scheduled for last Monday, it had to be postponed due to lockouts and road closures.

Aboriginal and Torres Strait Islander Heritage Protection Act 1984 (Cth) Notice of an application for the protection of a specified area, being the area known as Mount Peake Mine, near Wilora, Northern Territory

Invitation to make representations

I, Alice Buhrich, hereby give notice as follows:

The Minister for the Environment (Minister), responsible for the Aboriginal and Torres Strait Islander Heritage Protection Act 1984 (Cth) (Act), has received an application made under section 10 of the Act. The application is seeking long term preservation and protection of a significant Aboriginal area being the area known as Mount Peake Mine, near Wilora, approximately 251kms north of Alice Springs in Northern Territory. The Minister has appointed me to provide a report to the Minister under paragraph 10(1)(c) of the Act.

The Applicant

The application is made by Christine Palmer on behalf of herself and other Kaytej Traditional people (Applicant).

The purpose of the application




Figure 1 Map showing the specified area of Wilora

The application seeks the long-term preservation or protection of the area specified in the application (specified area). The specified area is depicted in Figure 1 below. Section 10 of the Act confers power on the Minister to make a declaration to preserve and protect an area where the Minister is satisfied that it is a 'significant Aboriginal area' under threat of injury or desecration. A 'significant Aboriginal area' is defined by section 3 of the Act as an area of land or waters that is "of particular significance to Aboriginals in accordance with Aboriginal tradition". 'Aboriginal tradition' is defined as the "body of traditions, observances, customs and beliefs of Aboriginals generally or of a particular community or group of Aboriginals, and includes any such traditions, observances, customs or beliefs relating to particular persons, areas, objects or relationships".

Matters the report is required to deal with

The Minister must consider my report pursuant to section 10 of the Act in relation to the specified area before deciding whether to make a declaration under section 10 of the Act. Under subsection 10(4) of the Act, the report is required to deal with the following matters:

- the particular significance of the area to Aboriginal peoples;
- the nature and extent of the threat of injury to, or desecration of, the area;
- (c) the extent of the area that should be protected;
- the prohibitions and restrictions to be made with respect to the area;
- the effects the making of a declaration may have on the proprietary or pecuniary interests of persons other than the [Applicant];
- (f) the duration of any declaration;
- (g) the extent to which the area is or may be protected by or under a law of the State or Territory, and the effectiveness of any remedies available under any such law; and
- (h) such other matters (if any) as prescribed.

The specified area

Figure 1 below depicts the area for which preservation and protection is sought. This specified area is described as the Mount Peake Mine, near Wilora, Northern Territory.

Claimed nature of the particular significance The Applicant claims the specified area is of particular significance in accordance with Aboriginal

- The specified area is important for the Wampere (Possum) Dreaming - Wampere (Possum) Dreaming songlines run in multiple directions, from coast to coast, including through the Walpri Tanami Desert and the Wampere (Possum) at Mount Peake and is therefore significant as a cultural and heritage site in song line and story.
- The specified area is a women's site and men are not allowed access to the area.

Claimed threat of injury or desecration

tradition for several reasons, including:

The Applicant claims that the specified area is under threat from the drilling and sterilisation proposed by mining company TNG Ltd. The threat is primarily attributed to drilling in the area and will threaten at least five fauna species which are part of the Mount Peake Dreaming.

Interested parties are urged to **contact me** as soon as possible to be provided with further information about the submission process, including the provision of the application, making representations in response to the application, and making final comments in response to representations received.

As part of the submission process, I will seek to take oral submissions from the Applicant, and if such occurs, any arising written record I make will be supplied to the other interested parties as a representation.

Representations must be made in writing by 5pm on Monday 22 November 2021 or within such further period as may be allowed. Do not send your representations directly to the Minister.

Representations received by the due date will subsequently be provided to the Applicant and to all interested parties who duly submitted a representation, and thereafter the Applicant and such interested parties will be afforded an additional period of two weeks to make final comments in writing

Claiming confidentiality

If you wish to claim confidentiality over any part of

your representation, please identify why you are claiming confidentiality and how you wish confidentiality to apply. Representations will be provided to the Minister for the Environment and the Department of Agriculture, Water and the Environment, along with the section 10 report. Representations, even those subject to confidentiality, may be disclosed where it is authorised or required by law, to meet procedural fairness requirements, and in response to a request by a House or Committee of the Parliament of the Commonwealth.

Personal information means information or an opinion about an identified individual, or an individual who is reasonably identifiable.

Sensitive information is a subset of personal information and includes any information or opinion about an individual's racial or ethnic origin, political opinion or association, religious beliefs or affiliations, philosophical beliefs, sexual preferences or practices, trade or professional associations and memberships, union membership, criminal record, health or genetic information and biometric information or templates.

By submitting a representation in response to the 'Notice of an application for the preservation and protection of a specified area, being the area known as Mount Peake Mine, near Wilora Northern Territory, you consent to the collection of all personal information, including sensitive information, contained in your representation.

I, Alice Buhrich, collect your personal information (as defined by the Privacy Act 1988 (Cth)) contained in your representation for the purposes of consideration in drafting a report under section 10 of the Aboriginal and Torres Strait Islander Heritage Protection Act 1984 (Cth) (Act) in relation the specified area and related purposes. If you do not provide some or all of any relevant personal information in your representation(s), I may be unable to fully and comprehensively consider your representation in the drafting of the report to be submitted for consideration by the Minister responsible for the Department of Agriculture, Water and the Environment (Minister).

The Department of Agriculture, Water and the Environment (department) collects your personal information (as defined by the Privacy Act 1988 (Cth)) contained in your representation for the purposes of the Minister's consideration in deciding whether to make a declaration under section 10 of the Act in relation to the specified area and related purposes. If you do not provide some or all of any relevant personal information in your representation(s), the Minister may be unable to fully and comprehensively consider your representation in deciding whether to make a declaration under section 10 of the Act in relation to the specified area.

The department may disclose your personal information to the Minister, parties that may be affected by a decision of the Minister under section 10 of the Act (to meet procedural fairness requirements), and other Australian government agencies, persons or organisations where necessary for the above purposes, provided the disclosure is consistent with relevant laws, in particular the Privacy Act 1988 (Cth). Your personal information will be used and stored in accordance with the Australian Privacy Principles.

Remote schools fine tune their swimming

FIFTY-TWO students from six remote schools travelled into Tennant Creek for three days of intense swimming lessons – not only to improve their swimming strokes but to gain that winning edge in the Barkly Region Swimming Carnival being held on day four of their visit in town.

Supported by Royal Life Saving NT, Swimming NT and Barkly Region Sport Education, the students were streamlined into groups and put through their paces over the three days. Some students were taught the basics in all three major strokes while others learnt not only how to improve their swimming but the correct way to dive for that all important start to a race. Swim



survival was also a part of their learning with basic reach rescues to rope rescues.

Water aerobics was on the agenda one morning to get the students all warmed up for their day in the water which everyone enjoyed.

Teachers said they could see a vast improvement in their students and especially when competing in the swimming carnival.
